Billing & Appointment Procedures

1. In order to fill as many requests as possible, ACAC reserves the right to assign specific courts within the Indoor Center for all reservations. When special events are held at ACAC, we reserved the right to move players to another court or cancel your court for that day.
2. The billing of court time will be calculated by multiplying the prevailing hourly court time rate by the number of weeks in the season for the day of the reservation.
3. Reservations for season court time will be charged in two installments, on October 18 and on January 15.
4. Although season court time cannot be cancelled, there may be times when a group is unable to play on a specific date. In the event this occurs, and the club is notified at least 24 hours in advance, ACAC will attempt to sell the court. If the court is sold, the Court Captain's account will be credited
5. ACAC reserves the right to decline requested court times for any reason deemed reasonable by ACAC management. Each application will be date stamped to confirm date received.

By signing below, I agree that I have read and understood the billing and appointment procedures, the amount that will be charged to my account, and that my selected court times are in no way guaranteed acceptance by ACAC management. I, also, agree that I have spoken to the other individuals listed as players for the court times, and they have agreed to be responsible for the charges placed on their accounts.
